Can't be done purely from top down!!!





### Family Governance John Davis – Harvard Business School

- Corporate governance is difficult enough...
- Add the complexity of family...
- Business, Ownership group AND FAMILY all need governance



### Family Governance John Davis – Harvard Business School

 Generates a sense of direction, values to live by or work by, and well-understood and accepted policies that tell organization members how they should behave or what they should do in certain circumstances.


• Brings the right people together at the right time to discuss the right (important) things.

### Family Governance The Simple Things

- Annual meetings with all professionals
- Advisory Board (later fiduciary)
- Policy for family entering the business
- Development plans for family members
  - Milestones, evaluation, non-family involvement (safety)



### Family Governance The Simple Things

- Agreement on meritocracy
- Common vision and mission
- REAL values statements
- Clear options for family who do not want to participate
  - Family and not "business"



### Family Governance The Simple Things

- Family story lessons, wisdom, values
- Ethical wills
- Operating agreements
- Shareholder/Buy-Sell agreements
- By-laws



### Family Governance High-Level Ideas

- Develop the positive
  - Deeply held values in action
- NOT only manage downside
- Family culture
- Senior generation focus???
  - A voice does not equal a vote!!!

- Often signed/memorialized by family

- Dividends
- Employment




### Family Constitutions Elements


- Shared family vacation homes
